Completed applications may be submitted to the Main Office of Hunger Task Force at 201 South Hawley Court, Milwaukee, WI 53214 starting at 9:00 a.m. on Monday, August 5, 2019. **The deadline to submit the completed application is 4:00 p.m. on Friday, August 16, 2019.** Organizations that distribute from multiple food service sites must provide complete separate applications for each eligible site.

All attachments must be included by the deadline for the application to be considered complete. Applications will not be reviewed by Hunger Task Force staff for accuracy or completeness at time of submission.
